The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Petition for Bounty Land

John Jones – Soldier C. L. [Continental Line]

There are several soldiers named John Jones whose names appear on the Army Register.

Carter Croxton Senior, a respectable witness, says that he knew John Jones of Essex County – that he entered the service of the United States as a substitute for Lewis Hall [could be Lewis Hale], sometime in the year 1776, for 18 months & served his tour of engagement – that he afterwards enlisted

for the war, in the Continental service and served to the end of it.

To his Excellency Governor Tazewell

The affidavit of Carter Croxton¹ of the County of Essex and State of Virginia, aged 73 years
This affiant being duly sworn according to law, states upon oath that he was well acquainted with
John Jones, who was a resident of the said County of Essex, that the said Jones Entered the service of the
United States in the revolutionary war as a Substitute for Lewis Haile, in the Continental service
sometime in the year 1776 under Captain Sayers [? perhaps John or Robert Sayres] ([one or more
indecipherable words] as he now remembers) for Eighteen months, and served his time fully out, and
afterwards enlisted for during the War in the Continental service, and went to the North, where he
remained until the close when he returned, and married and settled in the said County of Essex. This
affiant does not know what Regiment the said Jones belonged to, nor does he recollect under what officer
he enlisted, and served, but is well assured that he served his time of enlistment out, as he never saw or
heard of him after his enlistment until the expiration of the War, when he returned from the North and
married as before stated, and further this affiant saith not.
