[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



To the Honorable the Senate and House of Delegates of the Commonwealth of Virginia The Petition of John Verrel of the County of Dinwiddie humbly Represents. That he is the Legal Representative or Agent of Lewellin Jones of the County of Oglethorpe in the State of Georgia,

formally an Inhabitant of the State of Virginia, as will satisfactorily appear by Reference to the annexed Letter of attorney. That at an Early Period of the late Revolutionary War, the said Lewellin Jones entered into the service of his Country and was appointed by the State of Virginia to the Command of the 4<sup>th</sup> Company in the 1<sup>st</sup> Virginia Regiment of Light Dragoons and continued to serve in that Station for three years: That by the Existing Laws of this Commonwealth he was entitled to the full Pay and Emoluments of a Capt. of Dragoons as well as to a due Proportion of the Lands allotted for the Reward of those who rendered Military Services to their Country: Among whom none stood higher for Activity and Zeal in the Cause of Liberty than him who is Represented by your Petitioner. Your Petitioner knows too well the Justice, Liberality and Magnanimity of his Country men, for a moment to believe, that, whilst we are enjoying all the blessings of Liberty and free Government, The Representatives of the People will withhold the reward of Valor and Patriotism from the war worn Veteran by whose Toils and whose Blood, that Liberty was obtained: At a Period too, when the heart of every lover of his Country is glowing with Enthusiasm for the Recollection of the Imperishable Glory with which the Sons of Columbia have emblazoned his name (Virginians not the least among those Heroes). The mind naturally secures to the Recollection of those who by their Examples led the way to this Glory & taught an Admiring world that the forces of Freedom are always successful when [one or more indecipherable words] in the Defense of their beloved Country and the Rights of Man.

Various Causes combined to prevent Capt. Jones for many years from receiving the reward for his Services so amply provided by his Grateful Country: The principle of which was his Removal to the State of Georgia, a measure thought necessary by him as the best means at that Time of Repairing a Fortune injured if not entirely ruined by the Sacrifices which he had made in his Country's arduous Struggle for Independence. Since that Period however the full Allowance of his Bounty Lands, has, through the Medium of your Petitioner, then made at the Land Office as will also appear by the Annexed Certificates: In order to Procure this Bounty all the necessary Vouchers (then in the Possession of your Petitioner) were Exhibited; among them the original Commission of Capt. Jones, and as your Petitioner thinks were lodged by him with the Executive Department: the Commission however cannot now be found in the Archives of that Honorable Body nor has your Petitioner been able since to find it. It is with Satisfaction that your Petitioner observes, that the Legislature of Virginia on the 9<sup>th</sup> of February 1814 passed a Law requiring the Auditor to settle the Accounts of the Late Major Harrison, and to pay to his Representatives the full amount which should be found due to him for his Revolutionary Services, and Evidence that Republics are grateful and that the Meritorious Sons of Freedom never go without their Reward. Your Petitioner asked in the Name of Capt. Jones for the same Measure of Justice and confidently believes that he will not ask in vain and your Petitioner as in Duty bound will ever Pray &c

I William G Pendleton, Register of the said Land Office, do hereby certify that the above is a true copy of a certificate from the Executive department of this State on file in this office, and that it appears by the books of this Office that, on the 8<sup>th</sup> day of September 1804, for warrants for 4000 acres of land, viz. one warrant No. 5063 for 2000 acres, one No. 5064 for 500 acres, one No. 5065 for 400 acres, & one No. 5066 for 1100 acres, issued from this office, upon said certificate to "the Representative of Lewellin Jones" and directed to the principal Surveyor of the Lands set apart for the Officers & Soldiers of the Commonwealth of Virginia. Given under my hand and seal of office this 19<sup>th</sup> day of December 1816

[Power of attorney given by it Lewelling Jones in Oglethorpe Georgia on April 6, 1804 in powering John Verell as his attorney to petition the House of Representatives of the United States for such money as is due him for his service in the revolution.]

I do hereby Certify that I was acquainted with Lewelling Jones (of Amelia) and know that he commanded a Troop of horse, as Capt. in the old Revolutionary War, between Great Britain & America: That I saw the said Jones frequently to the northward, performing the said duties of a Capt.: and those duties were performed in or about the year 1777, 78 & upwards and I am not certain; but I saw him and doing duty before the above stated periods.
