Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

I do Certify that in the year 1776 or seven I enlisted a man by the name of George Jude who afterwards was attached to Captain Thomas Meriwether's Company of the 1st Virginia State Regiment under the command of Colonel George Gibson and in the year 1777 we were ordered to march to the main Army, and on our way to Head Quarters the said Jude was taken sick of which indisposition he died. Given under my hand this 25th of October 1826

Dear Sir

I have called at your office but I do not see the paper on your desk you promised to furnish me with.

I have spoke with Judge Marshall [presumably Chief Justice John Marshall] & he says without hesitation that the 1st State Regiment was raised for three years. If the Executive wants further Evidence of the fact will you be so kind as to ask him yourself.

In great haste-- I am Dear Sir Your Obedient Servant S/ Ro. H. Saunders

Heirs of George Jude allowed for 3 years as a private Continental line Certificate issued December 1st, 1826
