## Pension application of Richard Halbert VAS1359 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Spotsylvania Court September the 5<sup>th</sup> 1786

It is hereby certified by the Court that Mary Halbert a resident of this County and widow of Richard Halbert a Soldier who died in the Service of the Militia Ordered from this State for the relief of South Carolina is a proper object to receive a Pension, and that Indigency of circumstances render the same necessary.

I do with the advice of the Council hereby certify that Mary Halbert widow of Richard Halbert, a Private of the Virginia militia ordered to the relief of South Carolina who died in the service of the United States, is entitled to the Sum of Eight Pounds yearly to commence on the first day of January 1786.

Spotsylvania Court April 3<sup>rd</sup> 1787

Mary Halbert widow of Richard Halbert produced a Certificate from under the hand of His Excellency the Governor entitling her to receive the sum of eight pounds per annum to commence from the 1<sup>st</sup> day of January 1786 as a pensioner, and making oath that she is the person to whom it was given, and the Court having compared the said Certificate with the list transmitted from the Auditor and finding it to be right do hereby direct the sheriff to pay the said eight pounds agreeable to an act to amend the Act entitled and Act to amend the Act concerning Pensioners.

[Transcribers Note: The papers in this file appear to relate to the above matter only through page 39 of the 56 pages of this file. The bulk of those documents relate to the annual authorization, disbursement and receipt of the pension by the widow through 1795. The balance of the pages appear to relate to a disability pension allowed John Halfpenny of Frederick County who was a soldier in Captain Bruins[?] Company of the 11<sup>th</sup> Virginia Regiment on Continental establishment who received a number of wounds in the action at Buford's defeat.]

Possibly Peter Bruin
