## Bounty Land Warrant information relating to Gideon Hamblett VAS1365 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## [From bounty land records in the Library of Virginia]

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 24<sup>th</sup> day of July 1784, in the name of Gideon Hamblett, as a Soldier of Infantry for £15.19.8, which Certificate appears to have been delivered to Ed Valentine and was given for services prior to the 1<sup>st</sup> January 1782.

Given under my hand, at the Auditor's Office, Richmond, this  $7^{\text{th}}$  day of September, 1833.

## Charles City County to wit

This day old Mr. William Day of the said County personally appeared before me a Justice of the peace for the said County & made oath that he was personally well acquainted with Gideon Hamblett late of the said County, that he knows the said Hamblett was a soldier in the revolutionary service, that he enlisted for three years & served out his time & was a true & faithful soldier.

Given under my hand and seal this 19<sup>th</sup> day of September 1833 S/ Nathaniel Nelson

Petition for bounty land

Heirs of Gideon Hamlett [sic] Soldier Continental

His name is on the Army register. He received July 24, 1784 £15.19.8 the balance of his full pay. One credible witness proves his enlistment & service for a term of three years.

If your Excellency should allow land bounty – the allowance should be for a service of three years as a soldier of the Continental line.
