The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Virginia I do Certify that I was well acquainted with Lieutenant Joel Hardaway of the third South Carolina Regiment in our late War with Great Britain, and to the best of my recollection, he entered into the Army as such in the year 1777 and remained in the said Army till the year of 1781 or 1782. Given under my hand this 23rd of February 1810.

This day Mrs. Francis Tucker a respectable citizen of Nottoway County personally appeared before me W. H. Joins [?] a justice of the peace for the aforesaid County of Dinwiddie and being first duly sworn deposeth and saith that she was acquainted with Joel Hardaway, that he lived in the County of Dinwiddie and State of Virginia, That [several words too faint to discern], that he went into the Army during the Revolutionary War, and that at the end of the war he returned to his native County and State and died there.

House Statute at Large Vol. 10, p. 537

Resolved. That all Officers and Soldiers being citizens of this Commonwealth, belonging to any Corps of Continental establishment, and not being in the actual service of any other State, shall hereafter be entitled to all the State provisions, clothing, bounty and other emoluments either in land or money, which may have or shall be allowed to those belonging to the line of this State, although such Officers and soldiers do not immediately serve therein, and also to the six months pay presented to each Officer and Soldier by "And Act to enable the Officers of the Virginia line, and to encourage the soldiers of the same line to continue in the Continental service."

November 27, 1779
