Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Virginia County of Fauquier to wit

I David Haley heir at law of Daniel Haley Trumpeter do upon oath testify and declare to the best of my knowledge that my brother Daniel Haley did enlist at Guilford Court House and served in the Regiment No. 3 of Dragoons under the command of Colonel William Washington of the Continental line and that he continued in service aforesaid until slain in Battle at the Eutaw Springs [September 8, 1781]

I further declare that I have never received a warrant for the bounty land promised to him on the part of the United States nor do I believe he ever received it, or transferred his claim to it, in any manner whatsoever there for

Know all men by these presents that I David Haley aforesaid do hereby constitute and appoint John Balthorpe of the above State and County to be my true and lawful attorney for me and in my name to demand and receive from the Secretary of War of the United States a warrant for the quantity of Land due to me as aforesaid and my said attorney is hereby fully authorized and empowered to constitute and appoint one or more substitutes or attorneys under him for the special purposes above expressed.

Personally appeared before me William Gibson a Justice of the peace for said County Rush Hudson¹ a Revolutionary pensioner and made oath that the within mentioned Daniel Haley did enlist in the United States service at Guilford Court House in the 3rd Regiment commanded by Colonel George Baylor and afterwards served in Colonel William Washington's Troop of Horse until slain in Battle at the Eutaw Springs.

Personally appeared before me William Gibson a Justice of the peace in and for said County, Richard Garrard aged sixty-nine years and made oath that the within mentioned Daniel Haley, brother of David Haley, served in the Revolutionary War from about the beginning of the War until slain at the Battle of the Eutaw Springs and that he first enlisted for 3 years and afterwards for during the War; the above named Rush Hudson and Richard Garrard are to me well known to be men of respectability and truth.
