[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

This is to certify, that it appears from a list in this office of such Officers and Soldiers of the Virginia Continental Line as settled their accounts and received certificates for the balance of their full pay, according to an act of assembly, passed the November session 1781, directing the Auditors of Public Accounts to settle and adjust the pay and accounts of said Officers and Soldiers from the first January 1777 to 31st December 1781, (see Hening's Statutes at Large, vol. 10, p. 462,) that a settlement was made on the 12th day of [too faint to discern] in the name of William Henderson as Captain of Infantry and evidence of the indebtedness of the State to him was £132.6.2,delivered to E. Winston and was given, as appears by a copy of the settlement on file in this office, for services from the 5th January 1777 to 30 May 1778 and as Lieutenant from the first to the 4 January 1777

The deposition [of] James Davis¹ being first duly sworn deposeth and saith that he is 75 years of age and that he was Intimately acquainted with William Henderson who was a Lieutenant and Captain in the Revolutionary War. That he marched up in the 9th Virginia Regiment to the North in the year 1776 and continued in the Service until the end of the War and then returned home to the County of Accomack Virginia where he remained until his death.

The undersigned heirs at law of William Henderson deceased respectfully represent that their ancestor, the said William Henderson served as Captain in the 9th Virginia Regiment on Continental establishment from an early period to the end of the Revolutionary War.

They refer for proof of his service to the affidavit of James Davis, a revolutionary

pensioner of the United States, who deposes that the said Henderson marched in 1776 to the northward & continued in service to the end of the War. As confirmation of the accuracy of Davis's Statement, they refer to the [text too faint to discern] historical fact that the 9th Regiment was raised principally in Accomack County, where Davis resided. Residing in the same County with Henderson, he had the best opportunity of knowing his service.

They ask the usual allowance of bounty.
