Bounty Land Warrant information relating to Robert Hendren VAS1487 Transcribed by Will Graves 3/14/14 rev'd 2/28/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

I do hereby Certify that Robert Hendren made oath before me that he would be true to the Commonwealth of Virginia and that he will serve the same for the Term of three years as a Mattross [matross] in Captain John Mazaret's Company of Artillery. Witness my hand this 11th day of September 1777



To the Hon. Assembly of Virginia now Sitting The petition of Robert Hendren Humbly Sheweth

That he was a Soldier in Col. Thomas Marshall's state Regiment of Artillery and did Serve in the said Regiment three years the time which he enlisted for as will appear as [sic, in] certificate from under the Hands of John Mazaret Major and Peter Kemp Capt. of the same Regiment. That your Petitioner after receiving his discharge went to Sea to and from France until after the expiration of the time limited for bringing in such Claims. That your Petitioner did apply to Col. Merriwheather [Thomas Meriwether] Commissioner for settling Army Accounts and was informed by Col. Meriwether that he could do nothing in the matter as the time limited was Expired but that he would take in the Original Certificate and give Your Petitioner another of the same Tenor and date from under his hands which your Petitioner has Ready to produce Your Petitioner Therefore prays your Honors will Examine into his Claim and grant him payment And your Petitioner shall ever pray
