Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Petition for Bounty land

John Henley – Soldier – Continental Line

This soldiers name is on the Army Register – He received the sum of £15 – the balance of his full pay as soldier.

One credible witness proves that John Henley enlisted & served for three years, in the Continental Army. He appears to be entitled to land.

If your Excellency should allow bounty land it ought to be for a service of 3 years as Soldier in the Continental line.

Personally appeared before me Jonathan Hunter a Justice of the Peace for the said County Thomas Bonney who made oath that John Henley was a Soldier of the Virginia State line during the War of the Revolution and was in service three years and was Honorable discharged, and I certify that Thomas Bonney is worthy of credit. Given under my hand this [illegible] day of February 1832

I Thomas Bonney¹ of Princess Anne County do hereby certify that I was well acquainted with John Henley of said County. I recollect distinctly of his enlisting in the regular service in the revolutionary war about the year 1777 he went from this County to the North I understood from him when he came home which was after the siege of York, that he held the office of Sergeant whilst he was at the North. I know he enlisted for three years and he did not return home within three years, from the time he went away. I saw him frequently after he came home and conversed with him about the war. I lived about six miles from him he was raised in the County where I was born and raised at. I had frequent opportunities of seeing him after he came home from the North. I was in a volunteer company with him after he came home. I was not in the regular service myself. I am now drawing sixty dollars per year as a pension for my services in the revolutionary war. As witness my hand and seal this the 5th day of June A.D. 1832

[pp 9-10: last will and testament of John Henley of Princess Anne County Virginia; he names wife Francis [sic, Frances]; grandchild Jennet Henley daughter of William Henley to whom he leaves a Negro woman named Rose; son Johnson Henley to whom he leaves a Negro woman named Sarah; to his afflicted daughter Polly Henley he left a Negro man named America; son Edward to whom he left his plantation where he now lives together with his son's choice of the testator's guns; son James to whom he left one Negro girl named Judah and he to have second choice of the testator's guns. The will was probated in Princess Anne County Virginia July 7th, 1817.]
