Pension application of Lewis Hensley VAS1496 Transcribed by Will Graves vsl 5 3/17/14

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Virginia County of Henry Sc.

Lewis Hensley aged about 73 years being first duly sworn deposeth and saith that sometime in the spring of 1776 he enlisted in the County of Orange in the State of Virginia for the term of three years under Lieutenant Abraham Uray [?]¹ and served in a Company commanded by Captain John Marx [John Marks], in the 14th Regiment of the Virginia Continental line commanded by Colonel Charles Lewis and that he continued to serve faithfully in said Regiment until the expiration of his said term of enlistment; the deponent further says that after having served about one he was appointed a Fife Major which office he continued to hold through the whole of his services. Immediately after the expiration of his three years enlistment, he reenlisted for during the war, and obtained a furlough for three months to go home and see his friends, when his furlough was expired he again joined the Army and General Washington ordered Colonel Richard Parker (who then commanded the Regiment to which this deponent was attached) to proceed immediately with the regulars under his command to Augusta in the State of Georgia, the enemy then drove us back from Savannah to Augusta where we remained for some time, that the Regiment was then ordered to Charleston South Carolina and we were first under the Command of General Lyncon [Benjamin Lincoln] and at the siege of Charleston this deponent was taken prisoner by the enemy & was sent to [the image of this document cuts off at the bottom thereof at this point]

said services neither has he ever sold transferred or in any manner disposed of his claim to it. The deponent further says that he continued to act as a Fife Major until he was taken prisoner as aforesaid

I was well acquainted with the said Hensley and do therefore know that he did perform the whole of the services set forth in his declaration; and I further certify that the said Lewis Hensley is the identical man he therein presents himself to be.
