## Pension application of Elijah Hickman VAS1511 Transcribed by Will Graves

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Petition for bounty land

The Heirs of Elijah Hickman – Soldier Continental line

The only proof offered in support of this claim is the affidavit of Ro. Russell<sup>1</sup>, a revolutionary soldier, and said to be a respectable witness. The witness says he knew Hickman well – they were raised in the same neighborhood, in Accomack County – they belonged to the same Company in the 9<sup>th</sup> Virginia Regiment – they were in the battle of Germantown [October 4, 1777] together and the said Hickman was killed in that battle. The Company to which the witness & Hickman belonged was Captain Thomas Snead's.

To his Excellency Governor Tazewell

Accomack County to wit

I Robert Russell aged 76 do hereby certify and declare that I was a soldier in the 9<sup>th</sup> Virginia Regiment during the war of the American Revolution and that I was in the battle of Germantown near the city of Philadelphia – I further certify that Elijah Hickman and myself belonged to the same company in the same Regiment, and that he was in the battle of German Town, and was killed in the action: The said Hickman & myself were raised in this County and marched from here to the North under the command of Colonel Fleming [Charles Fleming] – Thomas Snead was the Captain who commanded the company to which I & the said Hickman belonged. Given under my hand this first of March 1834
