[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Louisa County to wit

This day personally appeared before me a Justice of the peace for the said County and state of Virginia Antony Winston¹ and made oath that early in the war of the Revolution that William Hogan enlisted for During the war under Captain Thomas Johnson of Louisa County and State of Virginia and that he always heard and firmly believes that the said William Hogan fell in Battle some where to the South and that Mary Hogan and Elizabeth Hogan and Francis Hogan all of the sisters and only heirs of the said William Hogan.

Given under my hand this 29th day of November 1831

The affidavit of John Fleeman Senior of Lawful age taken at his house on the 6th day of October 1831 deposeseth and saith that on the 16th day of August 1780 near Camblin [Camden] at General Gateses defeat [Battle of Camden, August 15-16, 1780] he saw William Hogan a Continental soldier of the Revolution fall in the line of battle & view to him afterwards and considered him dead.

Sworn to before me Peter McDaniel a Justice of the peace for Louisa County this 6th day of October 1831

Sir,

A claim is presented to you on the part of Miss Hogan of Louisa for the Bounty land of their brother – William Hogan – I think a Soldier of the Revolution – it is founded on the evidence of Anthony Winston & John Fleeman of Louisa. My purpose in addressing you is to assure you that Mr. Winston & Mr. Fleeman are both of them men of the first respectability – no man in our County stands higher – as a man [indecipherable word] for integrity and truth than Mr. Winston – & he is a very suitable intelligent man.
