[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 15th day of March 1783, in the name of Nathaniel Terry, ¹ as a Captain of Infantry for £553 .1.0, which Certificate appears to have been delivered to himself and was given for services prior to the 1st January 1782.

To Wit pay as Lieutenant from first January 77 to 26th of November 79 and as Captain from 27 November 79 to 31st December 1781

Given under my hand, at the Auditor's Office, Richmond, this 30^{th} day of April 1835.

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 1st day of March 1784, in the name of Joseph Hobson [sic], as a Lieutenant of infantry for £97.10.8, which Certificate appears to have been delivered to himself and was given for services prior to the 1st January 1782. I Joseph Ligon² formerly of Halifax County Virginia do hereby certify that I am now and have been for a great number of years personally acquainted with Colonel Nathaniel Terry who was also formerly of the same County and who now resides in Todd County in the State of Kentucky. I do further certify that I knew the said Nathaniel Terry before the revolutionary war

and that during the continuance thereof he was absent from home and that I was [indecipherably faint word or words] and believed that he was in the service and that he was a prisoner at the conclusion of the war and I continue in that belief. After the war was over we resided for many years in the same County in Virginia & I do further certify that I have personally known the said Colonel Terry since his removal to the state of Kentucky and that he now resides in Todd County of said state. He is a gentleman of high character [several indecipherably faint words] credit all to be given to any statement or certificate made by him & I also certify that I knew Joseph Hopson about the commencement of the revolutionary war, he was also a resident of said County of Halifax State of Virginia and that it was [indecipherable word] reported at the time that he and the said Nathaniel Terry entered into the revolutionary war [the image of this document as posted online cuts off at the bottom thereof at this point]

I also certify that I am now and have been for many years in the receipt of a pension from the United States for a wound received in the right shoulder at the battle of Guilford Court House [March 15, 1781] which disabled my right arm. Given under my hand this 21st of March 1835 S/ Joseph Ligon

I Robert Innes of the County of Fayette & State of Kentucky do hereby certify that I was intimately acquainted with Colonel Joseph Hopson deceased late of Christian County Kentucky. I became acquainted with the said Joseph Hopson in 1797 in the County of Henry & State of Virginia where I also became acquainted with his wife's sister whom I afterwards married. I then lived in the County of Franklin & State of Virginia which joins the County of Henry aforesaid. From that time until 1819 Joseph Hopson & myself were very intimately acquainted [indecipherable word] each other. In 1811 the said Joseph Hopson moved to the West & I afterwards twice visited him where he lived in Christian County & State of Kentucky & have since had satisfactory evidence that said Joseph Hopson is dead & that he left his son Henry Hopson his residuary legatee

do further certify that I have

him in that County in company with his old associates & have heard him acknowledged by many of them as an old Revolutionary Soldier – and always heard it said by him that he was a Lieutenant in Morgan's Regiment –

I do further certify that I was well acquainted with Colonel Nathaniel Terry when he lived in Halifax County Virginia & have been at his residence since he moved to Todd County Kentucky – And I do further certify that the said Terry & Hopson were always very intimate & fond of each other & always spoke freely to each other upon their services in the revolution. And that said Terry is a man of advanced age & was & is still a man of respectability – and I have understood is now drawing a pension for his revolutionary services from the government.

And I do further certify that his son Henry Hopson above named is now residing in Fayette County a near neighbor to me & is a Doctor of Medicine & that I have known him from a child

Report upon the claim of Henry Hopson heir & Residuary Legatee of Joseph Hopson deceased a Lieutenant in the Virginia Continental line, for bounty Land for his services

To the Governor

Sir

The facts, in this case are that Joseph Hopson (who is believed to be the Joseph Hobson named in the Journal of the Council and in the auditor's certificates herein after referred to (see the two documents filed marked No. 6) was Lieutenant in the 7th Virginia Regiment from the first of the year 1776 to the last of the year 1778, and perhaps longer, and served three years – (C Affidavit of Nathaniel Terry, who was a Captain in the said 7th Virginia Regiment – the Council Journal of November 15, 1776, and the auditor's certificate with the note endorsed on it.) – That he received on the first of March 1784 a certificate for £97.10.8 the balance of his full pay for services prior to the first of May 1782: [several words too faint to discern] the precise time of service, for which this pay was received cannot be ascertained, is that his account was settled, have been lost or mislaid (see Auditor's certificate & note endorsed on it.)

The deposition of Nathaniel Terry taken the [paper compromised and text illegible] day of February 1835 who being in the 80th year of age & duly sworn deposeth & saith that he knew Lieutenant Joseph Hopson of the 7th Virginia Continental Regiment at the time he first joined the Army which was at the commencement of the year 1776 and that the company was commanded by Captain Nath. Cocke [Nathaniel Cocke] under whom he said Terry enlisted as a private soldier and was shortly after appointed a Lieutenant and was promoted to be a Captain and commanded a company at the siege of Charlestown [Charleston South Carolina which ended with the surrender of Charleston on May 12, 1780] when he was taken a prisoner, paroled & never exchanged – And this deponent further states that [several words too faint to discern] saw Lieutenant Hobson while in service and knew him to be in the regular service of the 7th Virginia Regiment in & during the years 76, 77 and 78 and whether he continued in service or was a supernumerary, this deponent is unable to say.
