Bounty Land Warrant information relating to Bannister Howe VAS1624 vsl 5 Transcribed by Will Graves 5/3/14

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[From bounty land records in the Library of Virginia]

The affidavit of Mrs. Mildred Hobday of the County of Gloucester. This affiant states that she was born in this County Severn River and is now in her seventy first year of age. She recollects that the Row Galleys of Virginia were frequently in Severn River during the war of the Revolution. She knows that Captain Bannister Howe whose farm a joined to Gloucester Town, was attached to one of the said Galleys and that he was frequently in Severn River on board one of them from early in the war to within about six months of the siege of York. About six months prior to the surrender of that place [October 19, 1781], this affiant removed to York River, after which she has no recollection of Captain Howe. She can, she thinks, with confidence say that Captain Howe was in service on board one of said Row Galleys as late as the early part of the year 1781. What rank he had this affiant does not recollect.

The Affidavit of John Belvin. This affiant states that he was born in Gloucester County and has continued to reside therein. He is now in his sixty sixth year of age. He recollects very distinctly Captain Bannister Howe whose farm a joined to Gloucester Town. He remembers that Captain Howe was attached to one of the Row Galleys of Virginia during the War of the Revolution, and seemed to have command of her, but whether he was captain or master or what rank he had this affiant knows not. He recollects that when the British came into York River when Cornwallis was at York the Galley on board of which Captain Howe was retreated up the River. He does not recollect when Captain Howe died.

The facts of this case are – banister how was master of the *Henry*¹ Galley as early as July 1776 (see larger [?] Journal of the Navy Board.) – And continued in service until the early part
