## Pension application of Vincent Howell VAS1630 Transcribed by Will Graves

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Petition for bounty land

Heirs of Lieutenant Vincent Howell of the Continental Line

The heirs of Lieutenant Vincent Howell received 2666 2/3 acres of land for his revolutionary services, in the year 1784. It does not appear, that they were entitled to more land. There is no evidence whatever in the case except the proof of heirship.

I presume your Excellency will make no allowance of Land to the Heirs, in addition to that already made.

Dear Sir

I write to you in relation to a claim which I may have against the general Government, or the State of Virginia as the law of may have provided upon that subject, as the heir of William Howell and Vincent Howell. I sent being close Deposition to the War Department and received for answer that the claim was referral solely to the Executive and Council of the State of Virginia with this information upon the law that unless William & Vincent Howell enlisted for during the war and served until its expiration that they could claim nothing against the general Government, I would esteem it a high favor from you to give [the image of this document cuts off at the bottom thereof at this point]

and the necessary steps to be taken Lewis Powell you will see from the Deposition was the oldest son of William Howell and upon this principle his heirs are trying to get the whole claim in exclusion of the other heirs and if this claim should be one to be satisfied by Virginia it will be urged by a certain Willis Morgan of Muhlenberg County Kentucky as the agent of Lewis Howell the object of this letter is to ask such information of you as you may find convenient to give and to prevent the said Morgan from controlling the matter further than he is legally authorized to do, if Morgan should present this claim you will no doubt find that the heirship of Lewis Howell

was taken at his instance but when the heirship of others then Lewis was proven the witness was taken to Union County to get the Heirship of Lewis proven separately you will find from the deposition that William Howell was a wagon master and Vincent Howell was a Lieutenant in the revolution.
