Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Petition for Bounty Land

Abel Pettygrew—Seaman S. Navy

This seaman's name is owned the Army Register. He received (or Colonel Cropper received for him) a certificate for £27.15 – the balance of his full pay as Seaman – on the 24th day of April 1785.

Elkanah Andrews¹ (whose credibility has been often proved before the Executive, by certification now on file in the Executive Department) says that he was well acquainted with Abel Pettegrew – that he served on board the *Accomac* Galley from the time of her being ready for sea, to the time when she was dismantled & laid up – This time has been proved, in other cases, to have been more than 3 years.

I did not report Abel Pettygrew , entitled to bounty land, in the printed list no. 5 of Seaman &c entitled to land for Revolutionary services; because I did not find his name on the few pay rolls of the men of the *Accomac* Galley, which have been preserved – The proof offered now, on his being in the State Navy is conclusive.
