## Bounty Land Warrant information relating to John Philips VAS173 Transcribed by Will Graves

Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I do hereby Certify that Corporal John Philips Enlisted with me in the 2<sup>nd</sup> Virginia Regiment on the 10 day of July 1777 for the term of three years. Given under my hand this 17<sup>th</sup> day of April 1784.

This is to certify that Mr. John Phillips formerly a Corporal in my Regiment hath truly & faithfully Served the Term for Which he stood Engaged in Consequence of which and at his own Request he is hereby discharged from any Further Service in said Regiment his Term having Expired the 30<sup>th</sup> of July 1780 he is Entitled to Depreciation on pay up to the last day of November 1789 [sic ?] To full pay from that day to the last day of July 1780, Clothing I do not know that there is any due him.

I Certify that John Phillips formerly a Soldier in the 11<sup>th</sup> Virginia Regiment was enlisted in Captain Blackwell's Company sometime in September 1776 and served until he substituted a Man in his place as appears by his discharge –

The Bearer hereof John Phillips soldier in the 7<sup>th</sup> Virginia Regiment having furnished a man to serve out the balance of his time is hereby discharged from the Service – Given under my hand this 20<sup>th</sup> day of August 1779.
