The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." To the General Assembly of Virginia

The Petition of Catharine Connor widow & relic of John Connor deceased respectfully sheweth.

That early in the War with Great Britain her deceased Husband, John Connor, entered into the service of the United States under the command of Col. Williams Davis. That he said John Connor continued in the service of the United States under the command of Sundry other officers, as Sergeant, subsequent to Col. Davis's declining his Command until the close of the War; when in the Battle of Camden [Battle of Camden August 15-16, 1780, or Battle of Hobkirk Hill known as the 2<sup>nd</sup> Battle of Camden, April 25, 1781] he received a Wound in his left arm which rendered it useless, in consequence of which, he was examined by a Position; and deemed unfit for service. He was accordingly put on the Pension List, with the Annual Allowance of Sergeant's half pay.

That some small time after the capture of Cornwallis [Yorktown, October 19, 1781], he was appointed Door-keeper to the Executive Council, in which appointment he continued at £100 per annum, until his decease; and never after the first year made application for his Pension. That immediately after his decease, it was the good pleasure of the Executive, to curtail the Annual Allowance to fifty Pounds, and continued his Widow, your Petitioner, in the Appointment, on which she depended as a maintenance for herself and one helpless Infant; which after paying the hire and maintaining a man to assist her in officiating in that office, left your Petitioner less per annum than the Pension of her deceased husband. That she is bereft of even this little support, by the late appointment of the said hired man, Matthew Pate, by the Executive.

Your Petitioner, therefore, humbly prays that your Hon. Body will please to take her, and destitute Infant's situation into consideration, and placed her on the Pension list, or do whatever in your lenity generosity and Wisdom you may deem just and right.

And your Petitioner will ever Pray Catharine Connor Richmond, November 7<sup>th</sup>, 1791
