## Petition relating to Robert Ager VAS1909 Transcribed by Will Graves

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the representatives of the freemen of the Commonwealth of Virginia in General Assembly met.

The petition of John Ager, Robert Ager, William Ager, and Thomas Ager, Heirs and legal representatives of Robert Ager deceased, Humbly Sheweth

That by authenticated certificates herewith enclosed<sup>1</sup> it most fully appears that Robert Ager the Father of your Petitioners was enlisted a Soldier in the 12<sup>th</sup> Virginia Regiment on the Continental establishment in December 1776 and that he died in the Service of his Country in the time of her Glorious Revolutionary contest say some time in 1777 or 1778 – Your petitioners therefore Humbly conceive that they his legal Heirs and representatives are entitled to the whole of his bounty land and arrearages of pay for his services as an old Revolutionary Soldier – and your petitioners humbly pray that your honorable body will take their case under your most serious consideration – and your petitioners being all truly poor as in Duty bound will pray &c
