Petition regarding William Andrews VAS1911 Transcribed by Will Graves

The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the General Assembly of Virginia

At the Memorial of George Andrews a Citizen of Mecklenburg County Humbly Sheweth – that William Andrews the Brother of your Memorialist, enlisted into the Continental Service sometime in November or December 1775 in a Company commanded by Capt. Robert Ballard which was incorporated into the 1st Virginia Regiment, that the said William Andrews engaged during the War – but after a Considerable Service, died sometime in the winter of 1779 – that Capt. Ballard settled himself in Maryland so that your Memorialist the Legal Heir of William Andrews, could not obtain of said Capt. Ballard the necessary Certificate for an adjustment of the claim of your Memorialist before the expiration of the term allocated for the auditors to settle them – your Memo. therefore prays that this claim may be put upon the same footing with those similarly situated with it & he as in duty bound will pray.
