### Petition relating to John Badgett VAS1932 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable Speaker and Gent. of the House of Delegates The petition of Thomas Badgett humbly Sheweth

That his son while a Soldier in the Continental Service being very sick while Stationed at the City of Williamsburg and in that condition marched with the troops from thence to the Northward about fifty miles and being unable to proceed on the March your Petitioner obtained leave to carry him to his House where he remained no longer than he was able to repair to his duty. Your Petitioner being in needy Circumstances and unable to bear the Expense without increasing his need hopes and humbly prays your Hon. House will receive his petition and make such allowance as may seem Just & your petitioner as in duty Bound shall ever Pray.

This is to certify that Thomas Badgett made oath before me this day that his son John a Sick Soldier in the Continental Service under the command of Capt. Jouett [perhaps Matthew Jouett or Jewett] was at his house Sick and Unfit for Service three months and he has at the Expense of 20 Shillings in getting his Sick Home. Given under My Hand 17<sup>th</sup> of December 1777 S/ Richard Anderson

I do further Certify that the above Badgett is a near neighbor to me and that his son Reported to duty sooner than I thought he was fit for the same.

Petition for Bounty Land

John Badgitt [sic] Soldier C. L. [Continental Line]

John Badgitt's name his own the Army Register. He received March 4<sup>th</sup>, 1783 a certificate for £35.8 the balance of his full pay as a soldier of Infantry – which certificate was delivered to Mr. Duvall.

One credible witness – to wit – Jesse King, testifies, that he was well acquainted with John Badgett before & during the Revolutionary war; and well remembers that he enlisted in the Company raised & commanded by Capt. John Watkins in the year 1776 and marched to Norfolk with the said company to join the Continental Army. That when he reached Norfolk, he was taken sick & sent to the Hospital. That he returned home on furlough; but soon recovered his health, went on to the North, and served out the term of his enlistment, which was 3 years – and that he afterwards returned home

To Gov. Tazewell

The affidavit of Jesse King of Surry County in Virginia taken at his dwelling in the said County the 28<sup>th</sup> day of May 1834. The affiant being duly sworn saith that he was well acquainted with John Badget of the said County before and during the Revolutionary War and well remembers that John Badget enlisted in the company raised and commanded by Capt. John Watkins in the year 1776 and set off with the said company to go to the North to join the Continental Army, and when he got to Norfolk he the said John Badget was taken sick & after being in the Hospital some short time, he was furnished with a furlough to return home until he was well, that he did return home, but in a short time, he got well, and went on to the North, & served the time of his enlistment out, & returned home again; his time of enlistment was for 3 years.

This is to Certify, that it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session, 1781, that a certificate issued on the 4<sup>th</sup> day of March 1783, in the name of John Badget as a Soldier of Infantry for £35.8.0, which certificate appears to have been delivered to Mr. Duval and was given for services prior to the 1<sup>st</sup> January, 1782
