Pension application of Samuel Hill VAS1940 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honourable the Legislature of Virginia

The petition of Samuel Hill of the County of Louisa humbly Sheweth – That your petitioner is an old Continental soldier, who enlisted as a private in the year 1776 under Capt. Thomas Johnson, and served the two eventful years of 76 & 77 – during which time, it was the fate of your petitioner, to be engaged in a most active and severe service -1^{st} at the siege of New York – 2nd at the action on Harlem Heights [September 16, 1776] on New York Island where your petitioner was badly wounded, belonging at that time to the 3rd Regiment of the Virginia Continental's commanded by Cols Marshall [Thomas Marshall] and Weedon [George Weedon] – 3^{rd} at the action on the White Plains [October 28, 1776] – 4^{th} at the Battle of Trenton [December 26, 1776], 4th at that of Princeton [January 3, 1777], and 6th at the Battle of Brandywine [September 11, 1777]. Besides these actions, He was engaged in various skirmishes at Brunswick – Somerset Court house – Germantown [October 4, 1777] – and on the lines of Philadelphia. That your petitioner although considerably lamed by the wound received on Harlan Heights continued in service, and regularly served the two years for which he was enlisted. And that he has never received his bounty lands or any compensation in lieu thereof. That your petitioner, so long as he had health and strength, refused to become a burden to his Country, which with an openhanded liberality, was daily ministering to the wants, and relieving the necessities of the War worn veteran of the revolution. He therefore continued to struggle with his difficulties, and although lamed by his wound, for life, and at times suffering excruciating pain, He has contrived, until within a year or two past, by his own exertions, to support himself and family. But these have now failed him. For the last two years he has derived his chief support from the liberality of a few kind friends. And for the last six months, He has been totally bereft of the use of his limbs, and as helpless as an infant. Bowed down therefore by that complication of ills – old age, disease and poverty, and surrounded by five infant children, looking up in vain, to him, for that pittance necessary to support life, On the very verge of the Grave, his wants, have wrung from him, this appeal; to the Justice and liberality of his native State. Your petitioner therefore approaches your Honourable Body with a confidence springing from the conviction that his case requires only to be known to receive at your hands that prompt relief which will soothe the last remnants of at [sic] life; the prime and vigor of which; was expended in the services of his Country. And your petitioner as in duty bound will ever pray &c &c

This will certify that we have examined Samuel Hill & find a Decrepitude of his left Ankle & Leg which he states to have been brought on by a wound received in the Revolutionary War at Harlem Heights which Decrepitude entirely disabled him from Labour.

Virginia Louisa County to wit

Personally appeared before us magistrates of the said County Abraham Davis of said County who being first duly sworn declareth and saith that he served in Weedon's, afterwards Marshall's Regiment with Samuel Hill, a private in Capt. Thomas Johnson's company during the year 1776 and 1777, and that the said Samuel Hill was severely wounded during the revolutionary war. That he was engaged in the Battles at Harlem Heights, Trenton, Princeton, Brandywine, New York and White Plains.

At a Court continued and held for Louisa County on Tuesday the 12th of November 1811 Samuel Hill, this day came into Court and made oath that he was enlisted in the year 1776, for two years as a Soldier in Capt. Thomas Johnson's company in the 3rd Virginia Regiment commanded by Col. Weedon, in the Continental Army of the United States, that he served the time for which he was enlisted, and that he has never heretofore proved, nor received any compensation for his bounty in land; all which is by the Court ordered to be certified to the
