Petition of Richard Chenowith VAS1956 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." To the Honourable the General Assembly of the Commonwealth of Virginia
The petition of Richard Chenowith
Humbly Sheweth

That your petitioner in January 1781 was employed by Col. George Slaughter and Capt. William Shannon to build one Square of Fort Nelson [at the Falls of the Ohio River, now Louisville] (the Stipulated sum being Twelve thousand pounds) Your petitioner immediately employed workmen and perfected the same Public credit being at a low ebb no person could be induced to undertake the remainder of the Work. Your petitioner was then Applied to and every possible argument made use of to induce him to undertake it.

Accordingly I undertook it on condition that six men mutually chosen viz. Capt. John Todd, Col. William Pope, Capt. William Oldham, Capt. James Patton, Henry Floyd and Benjamin Pope should as soon as perfected estimate the same, the Fort I finished on the Eleventh March, the Work was also valued at thirty thousand seven hundred twenty-five pounds to be [paper damaged and text rendered illegible] Value which was forty for one the Notorious custom of Exchange in this District at that time; Your petitioner never was an Opulent man and having employed a great number of Workmen to complete my engagement, and paying them off while able, the rest of them bringing Suits have reduced your Petitioner almost to beggary together with a small helpless family notwithstanding the manifold Injuries sustained by your petitioner for want of an adequate compensation, and still [indecipherable word] entire Confidence in your Honourable house humbly prays your Honourable house to take my Deplorable Situation in consideration and grant such specoly [sic, specify or specially?] relief as you in your great Wisdom shall Judge necessary and your Petitioner as in duty Bound Shall ever pray.
