Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Hon. the Speaker and Members of the House of Delegates

The petition of Elizabeth Alley, most humbly Sheweth that your petitioner's late husband, David Alley deceased Enlisted as a Soldier in the service of the United States on the 7th day of August 1780 for the term of Eighteen Months – that he continued in the said Service pursuant to his Enlistment until the 17th day of January's 1781 when he was attacked with a Complaint of which he died, leaving your petitioner with a family of seven [?] small children all of whom were incapable of assisting your petitioner in procuring the necessaries of life – your petitioner is not only in Indigent circumstances but also aged and Infirm, and consequently unable to procure those comforts without which life is only a misery and being until very lately entirely Ignorant of that provision which the policy and Virtue of the Laws established at that eventful period at which her deceased Husband was induced to enter into the Service of his Country, has never sought any relief at the hands of the Commonwealth and now humbly prays that your Hon. House will take her case into Consideration and allow her such Annual pension or other reasonable support as to your wisdom and Justice shall seem right and your petitioner as in duty bound shall ever pray &c

Elizabeth Alley appeared before the Court, as the Widow of David Alley, a soldier, who died whilst in the Continental service during the late American War to prove her marriage with the said decedent: Whereupon William Alley & Peter Cottrell being sworn, deposed, that in the lifetime of the said Decedent, they were well acquainted with him and the said Elizabeth – that they lived together as man and wife for upwards of 20 years, and it was generally admitted and



reputed that they were married, having never heard any report to the contrary of such a received opinion, Which is ordered to be certified.


