## Petition relating to Larkin Farish VAS1989 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Speaker and House of Delegates

The Petition of John Farish humbly Sheweth.

That Larkin Farish sometime in the fall of the year 1776 enlisted a Soldier for three years in the company of Marines commanded by Captain Alexander Dick.<sup>1</sup> That he with the others were put on board the *Musquito* [*Mosquito*] Brig,<sup>2</sup> and were taken near Barbados in June 1777 and confined in Goal [Jail] many months in that Island.

That the Prisoners were taken out of Goal by small numbers, put on board an English fleet and carried to Jamaica, where many of them were pressed on board an English Ship; since which, the said Larkin Farish hath not been heard of, and is therefore presumed to be dead.

That your Petitioner is the legal representative of said Larkin, and would have made application for the pay and depreciation due to him, at an earlier period, could he have obtained the proof necessary to establish the facts on which his claim was grounded.

That the Act of Assembly for adjusting & settling these Claims having been repealed, Your Petitioner therefore hath no other tribunal to resort to for relief but this Honorable House, who he prays to take his case under consideration, and extend that relief to him which they have granted to others in a similar case.

[The following are from rejected claims in the Library of Virginia.]

I hereby Certify that Larkin Farish [the rest illegible]

Spotsylvania County to wit

This day William Stanley personally appeared before me a Justice of the peace for the County and made oath that some time in the year 1776 Larkin Farish inlisted as a [illegible] soldier for three years under Lieut. George Catlett [W2524] and a short time after the said Larkin Farish was taken prisoner and have [illegible] Given under my hand this the 28<sup>th</sup> day of may 1821 Wm F Fulcher [other side]

Caroline County to wit

This day Moses Stanley [Moses Standley (Stanley) W3886] of lawful age appeared before me and made oath that the within named Larkin Farish served in the Marines service [several undeciphered words] were taken prisoners [the rest mostly undeciphered]

The heirs of Larkin Farish Pray that a land warrant may issue in there favour for the Quantity of Land that they are intitled to and all the pay the aforesaid Larkin Farish was intitled to for his Services from the time of his Enlistment to the Expiration of his services.
