Petition relating to James Cluverius VAS1996 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." To the Legislature of Virginia

Your petitioner respectfully States that his uncle James Cluverius of the County of Gloucester, was a Lieutenant in the State line during the Revolution, and was an officer during the whole war, and never did receive his Commutation or half pay, that he died intestate about the year __ and your petitioner has qualified on the estate as administrator, and is now the legal representative. He prays that he may be allowed in this case the Commutation or half pay due for his Uncle's Services. Your petitioner has been fortunate in this case in obtaining positive testimony that Lieutenant James Cluverius was an Officer of the State line at the actual termination of the war. He has moreover found his name on the list of Officers who were certified to be entitled to half pay about the close of the war. There cannot be a Shadow of Doubt to the fact of Lieutenant Cluverius's Services. Your petitioner therefore prays that the like allowance of Commutation pay may be made to him as representative aforesaid on account of Lieutenant Cluverius's Services, as has been to others.

I hereby certify that I was well acquainted with James Cluverius who served as an officer in the State line holding the rank and title of Lieutenant in the Virginia Regiment under Colonel ___. I knew him when he marched to the North and when he returned. He continued in Service till the end of the war 1783, I always heard him Spoken of as an active and meritorious Officer. Given

I do hereby certify that I was well acquainted with James the various formerly of the County of Gloucester and who was an officer in the State Line during the Revolution, he was absent from the County several years, and I well remember when he returned about the close of the war. James Cluverius was spoken of as an active & brave officer. Given under my hand this 13th day of January 1830

Cluverius, James, Lieutenant, Edmonds' Command, Artillery; com [commission] dated April 23, 1780. Name appears on a list of officers of a Regiment of Artillery raised for the defense of Virginia under command of Colonel Thomas Marshall. Awarded 4000 acres. [Plain text added]
