[The following are from rejected claims in the Library of Virginia.]

I Richard Ripley [S11299] of the County of Mathews & State of Virginia do hereby certify & declare that I was well acquainted with Phillip Brumley formerly of that part of Gloucester County called Kingston parish now constituting Mathews County. The said Phillip Brumley did enlist in the Virginia State line on board the gally Henry Captain Robert Tompkins [R102] in the year seventeen hundred and seventy six or seventeen hundred and seventy seven as a Seaman and served in said service untill the end of the war: As witness my hand & seal this the fifth day of March A.D one eight hundred and thirty four.

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia State Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session, 1781, that a Certificate issued on the 13th day of April 1787, in the name of Philip Bromley as a Seaman for £39.0.6, which Certificate appears to have been delivered to Wm. Reynolds and was given for services prior to the 1st January, 1782.

Philip Bromley, seaman Navy

[several undeciphered words] He received a certificate for £39.0.6 the bal. of his full pay as Seaman.

Richard Ripley a credible witness, says that he knew Philip Brumley very well – that he enlisted on board the Henry galley in 1776 or 1777 and continued in service to the end of the war.

In the Papers of the Henry galley, in Vol. 2 of papers concerning the navy Philip Brumley is enrolled among the Seamen of the s'd navy, belonging to that Vessel. He has been reported entitled to land for a service of three years, in the printed list of Seamen &c No 5. Resp'y submitted

The deposition of Matthias Gayle [S16818] who says he is 74 years of age. I Mathias Gayle do hereby Certify that I was well acquainted with Phillip Brownley formerly of that part of Gloucester County caled Kingston parish now constituting Mathews County the said Phillip Brownley enlisted under Capt Robert Tompkins in the year 1776 or 77 in the virginia State Navy on board the Henry Galley for the term of three years but continued in the virginia navy untill the end of the War by frequently seeing the said Brownley whilst he was attached to said navy Given under my hand and seal this 21st day of July in the year 1835

The memorial of John Brumley Polley T Brownley of the County of mathews and state of virginia and Thomas C Brownley[?] of the county of northumberland and State of virginia that these are the Children and only airs of Phillip Brownley that they claim to be entitled to Bounty Land in right of the said Phillip Brownley – that said Phillip Brownley was a resident of Kingston Parish then a Part of Gloucester now constituting mathews County that during the Revolutionary war in the year 1776 or 1777 he enlisted under Capt Robert Tompkins on board of the henry Galley as a seaman in the state navy and served in said navy untill the end of the War as your memorialists are informed and varily believes

Your memorialists varily believe that Phillip Brownley never received the Land Bounty to which he was entitled and pray that their claim to the same may be argued into by your Honour. In testimoney of the foregoing facts they have hereunto subscribed their names this 13th day of July in the year 1835 John Borum Jnr

Report on the claim of the heirs of Philip Brownley, (or Brumley) a Seaman in the S. Navy, for bounty land for his services.

To the Governor/ Sir,/ The name of Philip Brumley or Bromley (or Brownly) is on the army Register of the State line. He is there [undeciphered word] as a Seaman in the state navy, and as having received (by Wm Reynolds) April 13, 1787, a certificate for £59.0.6 the bal. of his full pay &c.

His name is on a list of officers & men of the Henry Galley, sign'd by Ro. Tompkins, without date; which list may be found in vol. 1 Navy Papers under the head Henry Gally.

A witness of respectable character has prov'd that Philip Brownly enlisted under Capt. Ro. Tompkins, of the Henry Galley a vessel of the State navy, in the year 1776 or 1777, for the term of 3 years, and serv'd to the end of the war (see the affidavit of Mathias Gayle.)

It does not appear that bounty land has ever been allow'd for the services of Philip Brownley, or Bromly, or Brumley.
