[The following are from rejected claims in the Library of Virginia.]

I John M. Foster of the County of Norfolk and State of Virginia [several undeciphered words] of the county and state aforesaid [undeciphered] daughter and sole heir at law of [several undeciphered lines] I believe was in the battles of Germantown [4 Oct 1777] and Brandywine [11 Sep 1777] and the said [undeciphered] served untill the close of the war [several undeciphered words] in the County of Norfolk and state of Virginia on the [illegible] day of Dec'r. 1813.

Personally appeared before me a Justice of the Peace for the County and State aforesaid Thomas Brookes who did make oath that John Brooks enlisted in the year 1778 in the Virginia Line and received an honourable discharge at the close of the War and I certify that Thomas Brooks is an Old Gentleman whose testimony may be relied on. Given under my hand and seal this 28th day of December 1834 T Webb J.P.

The memorial of Jno M Foster and Sarah his wife, who is the only heir at law of John Brooks, respectfully represents that the said John Brooks was a Soldier in the Virginia Line. that he enlisted in the year in Cap Wm Grymes's Company and served until the end of the war, as they believe. That he was discharged at Richmond Virg'a sometime in the year 1783

Your Memorialists are residents of the Town of Portsmouth, Norfolk County. They respectfully present the accompanying evidence of the Services of John Brooks and pray that their claim may be refered to the Commissioner of Revolutionary Claims
