Virginia documents pertaining to Francis Brown VAS2691 Transcribed and annotated by C. Leon Harris.

[The following are from rejected claims in the Library of Virginia.]

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia State Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session, 1781, that a Certificate issued on the 30th day of April 1785, in the name of Francis Brown as a Steward for £15.16.0, which Certificate appears to have been delivered to Henry Hill and was given for services prior to the 1st January, 1782.

Given under my hand at the Auditor's Office, Richmond, this 23rd day of January 1834.

Personally appeared before me Henry L [undeciphered] a Justice of the peace for the County of Gloucester in the state of Virginia Mr. Joshua Singleton [S7510] of the said county of Gloucester & state of Virginia and made oath That he was well acquainted with Francis Brown who was a Steward on board the Henry Galley commanded by Capt Robert Tompkins [R102] during the revolutionary war but how long he served I do not know as he was on board when I was transfered as first Lieut from on board the Mandley [sic: *Manley*] and from the Mandly on board the Ship Dragon I left the said Francis Brown on board the said Henry Gally I am inclined to think he enlisted and served three years as the men were enlisted for that term Given under my hand & seal this nineteenth day of July 1833

I Richard Ripley [S11299] of the County of Mathews & state of Virginia do hereby certify and declare that I was well acquainted with Francis Brown formerly of that part of Gloucester County called Kingston parish now constituting Mathews County. The said Francis Brown did enlist in the Virginia navy on board the Gally Henry captain Robert Tompkins in the year seventeen Hundred and seventy six or seventeen hundred and seventy seven as a Stewart and served as I allways understood and believe untill the end of the war. The memorial of Spencer Brown of the western country Nancy Gayle and Frances Walden of the County of Mathews and state of Virginia [several undeciphered words] state that the said Spencer Brown resides in the Western Country said Nancy Gayle and Frances Walden [two undeciphered words] the county of Mathews and state of Virginia that said Spencer Brown is the son of Francis Brown and said Nancy Gayle and Frances Walden is the daughter and heirs of said Francis Brown that they are the only heirs that they Claim to be entitled to Bounty [several undeciphered words] the said Francis that said Francis Brown was a resident [several undeciphered words] parish then a part of Gloucester County Virginia that during the Revolutionary War in the year 1776 or 77 he entered the state service in the navy of virginia that he

enlisted on [undeciphered word] the Galley Henry under Capt Robert Tompkins in the capacity of steward and served in that Character untill the end of the war [several undeciphered words] in service As your memorialists are informed and verily believe.

Your memorialists verily believe that Francis Brown never received the Land Bounty to which he was entitled and pray that their claim to the same may be [undeciphered word] into by your Honor In testimony of the foregoing facts they have hereunto subscribed their names this the 20th day of April 1835 Witness Jno.
