Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Petition for Bounty Land

Henry Purcell – Soldier – S. line [State line]

This soldier's name is on the Army Register – He received £11.1.2 the balance of his full pay as a Soldier.

The credible witness says – that he enlisted in the Second State Regiment, in the year 1777 & was discharged in the year 1781; having served the full term of his enlistment, which was three years. This soldier appears to be entitled to bounty land.

If your Excellency should allow bounty land it should be for a service, as Soldier in the State line, for a term of three years.

To his Excellency Gov. Tazewell

I Alexander Shackelford of King and Queen County do hereby certify that I was well acquainted with Henry Purcill [sic] who was a private soldier in the Second State Regiment in the revolutionary war, he enlisted for three years and marched to the North at the same time [one or more indecipherably faint words] which was in the year 177? [last digit to faint to discern], I enlisted in the year 1777 and marched to the North in the year 1778 and arrived at Valley Forge on the 27th of May in the same year the said Henry Persill [sic] came home about the same time I was discharged which was in the year 1781. I received my discharge from Colonel Allison in Petersburg the said Pursill [sic] entered the Army in the year 1777 and was discharged in the year 1781 having served his three years out faithfully, I was under the command of Captain Abner Crump in the first Virginia state Regiment. As witness my hand and seal this [illegibly faint] day of November in the year 1833
