## Bounty Land Warrant information relating to William Pyle VAS314 Transcribed by Will Graves

I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I do Certify that william piles [sic] was an officer in the Virginia Continental Line to the best of my knowledge he went to Boston with Captain Hugh Stephenson and served a year with him was in the year 1776 appointed a Lieutenant under Captain William Brady, was taken prisoner at Fort Washington in the latter part of the year 1776 when he was discharged. I cannot tell I have heard not until 1781 at Chesterfield in Virginia, but remember nothing about it but have it from an officer that was at that arrangement.
