I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

The [indecipherable word] of the heirs of John Oakly [sic[ to Land bounty To his Excellency the Governor of Virginia your Petitioners the heirs of John Oakly deceased that he entered the service of the United States in the war of the Revolution perhaps in the year 1779 and that he served in the Company of one Robert George that commanded the Artillery in the Regiment of Colonel John Montgomery and General George R Clark [George Rogers Clark] and that he then acted as a gunner in that Company until the end of the War of the Revolution. Your petitioners are all now residing in the County of Bath in the State of Kentucky and believe that the claim of John Oakly has never been presented for Land bounty therefore your Excellency will take the same into consideration and allow the quantity of Land Warrant do by law to them and in duty bound will ever pray & so forth.
