This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session, 1781, that a Certificate issued on the 30th day of November 1785, in the name of John Elliott as a Soldier of Infantry for £24.19.0, which Certificate appears to have been delivered to Colo. Cropper [John Cropper W3781] and was given for services prior to the 1st January, 1782.

I certify that Hillary Mears [S18508] a Revolutionary pensioner & a man of truth & veracity came before me & made oath that he was well acquainted with William Elliott, Teackle Elliott & John Elliott, & that they all enlisted for the term of three years in the 9th Virginia Regiment & were captured & imprisoned at Germantown [4 Oct 1777] & were in service & imprisonment nearly or quite four years. Given under my hand & seal as a Justice of the peace in & for Accomack County this 29th day of Jany 1834

Levin Hyslop [W7858] a Revolutionary pension & a man of truth & veracity came before me & made oath that William Elliott, Teackle Elliott & John Elliott of this County enlisted in the 9th Va Regt with the witness for the term of three years and were captured at Germantown & imprisoned & were in service & imprisonment nearly or quite four years. Given under my hand & seal as a Justice of the peace in & for said County of Accomack this 29th Jany 1834
