Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

To his Excellency the Governor of the Commonwealth of Virginia: The Memorial of the Heirs and legal representatives of "William Neal," late a soldier of the state line of Virginia on Continental establishment in the war of the Revolution: respectfully sheweth:

That your Memorialists were too young to have any personal knowledge of the services of said "William Neal" in the Revolutionary war: and have to depend on the evidence of Lieutenant John Crute¹ of the same company and Regiment –

That the said "William Neal" sometime in 1777 enlisted under Captain James Foster, to serve for the period of three years, and was attached to the 15th Virginia Regiment on Continental establishment, commanded by Colonel Ennis [James Innis] – That the said "William Neal," served faithfully the said term of three years, and was honorably discharged from service. All of which will appear, by reference to the accompanying certificate of Lieutenant John Crute, one of his officers, belonging to the same company & Regiment –

Your Memorialists further state, that the name of said "William Neal" appears on the Army Register of the Continental line, and has not been allowed Land Bounty for his services –

Your Memorialists therefore, pray that as the [image of the document cuts off at the bottom thereof at this point] [next page] for 3 years services in the State line of Virginia on Continental establishment, pursuant to the laws of Virginia in such case made and provided And as in duty bound, shall ever pray &c

I do hereby certify that I was acquainted with William Neal in the Revolutionary war, and no the fact that said Neale was a soldier under Captain James Foster, and attached to the 15th Virginia Regiment on Continental establishment commanded by Colonel Ennis – According to
