Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." To the honorable the Speaker and Members of the house of Delegates The Memorial of Lieutenant Colonel William Nelson humbly represents

That your memorialist was among the first who took arms against the British King in the late glorious contest; that he served as a common soldier on the volunteer establishment; that in that service he actually enlisted a considerable number of Men, as did indeed many other gentlemen of this State; that he was appointed Major in the seventh Virginia Regiment; that he rose to the rank of Lieutenant Colonel in the Continental line; that after having served two years in the regular Army, not without some degree of credit, he flatters himself, and when he had actually a right to a full Colonel's commission, the ill state of his health obliged him to retire from the Army, which he did with the permission of his excellency the commander in chief [George Washington]; and that since that time he has in every invasion had the honor to command regiments of Militia. Your memorialist therefore hopes your honorable Assembly will take his case under consideration, and allow him such bounty in land as has been bestowed on gentlemen in a similar predicament, and as to them may appear just.
