Bounty Land Warrant information relating to William Nelson VAS378 Transcribed by Will Graves

I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I do certify that William Nelson was appointed a Lieutenant in the Continental Army in my company in the 3rd Virginia Regiment sometime in February 1776, & died about January or February 1777.

To the Governor of Virginia

The petition of William Shutte for himself & the other heirs of Lieutenant William Nelson respectfully states; that said Nelson entered the Virginia Continental line in February 1776 and died in service in 1777.

See the affidavit of Captain John Ashby – The Council Journals of 22 July 1776, when he was at that time in the 3rd Virginia Continental Regiment.

The Bounty for 3 years service has been received. - The petitioners asked the additional bounty from February 1776 to the end of the War.



To his Excellency the Governor of Virginia

Your memorialists Thomas Nelson of Prince William County respectfully represents that his uncle William Nelson was commissioned as a Lieutenant in the Virginia Continental line 3rd Regiment early in the War of the Revolution and entered said Service, and after serving a Campaign he died in the said Service. Your memorialists being a nephew & one of the heirs of said Lieutenant William Nelson & having been lately advised that the Virginia Government would on proper application grant to the heirs at law of said William Virginia land Bounty as for a service of 3 years – your memorialists requested a statement of the facts in this case from Chief Justice Marshall [John Marshall] sometime sense and on receiving his letter, which is here with file your memorialists considering his remarks as applying to all [image of the document is cut off at the bottom thereof at this point] [next page] claim for land for 3 years may be referred for examination – and that the same may be allowed & he will ever pray &c

Richmond Jany 3d 1835

Dear Sir

I received your letter of November and supposed your inquiries to respect Colonel William Nelson of Caroline who was also in the Continental service during the war of our revolution. I answered your letter with this understanding of it. On looking over my letters before I set out for Washington I reperused yours and am satisfied that your inquiries relate to Mr. William Nelson of Fauquier [County].

I was very well acquainted with him before the war of the revolution and know that he was appointed a Lieutenant in the Culpeper Minute Battalion which assembled at Culpepper court house on the first of September 1775 and marched soon afterwards to Williamsburg. He was appointed a Lieutenant

Report upon the claim of the air of Lieutenant William Nelson, of the Continental line, for bounty land for his services

To the Governor

Sir

I report to your Excellency the following facts, which are all of which I have any knowledge, in relation to this claim –

The Journals of the Council show that on or about the 22nd July 1776 William Nelson was a Lieutenant in the 3rd Virginia Regiment. It does not appear, when he was commissioned. He did not settle his accounts with State Auditor, or with the Continental Commissioner; and his name does not appear on the Army Register of the Continental line.

William Nelson Lieutenant of the Continental line received 2666 2/3 acres of land on the 9^{th} day March 1797 which was allowed to him for a service during the war. It is not in my power to say whether or not this was the officer, whose air is now claiming bounty land.

quainted with William Nelson of Fauquier – that he was appointed a Lieutenant in the Culpeper minute Battalion which assembled at Culpepper Court House on the first of September 1775, and marched soon afterwards to Williamsburg. That he was appointed Lieutenant in the 3rd Virginia Regiment, in the company commanded by Captain John Ashby, which marched to the North in 1776, and served one of the severest Campaigns known in America – that he believes (but is not certain of the fact) that the said William Nelson died in the winter of 1776 – 7 – that he (the witness) served in the same Brigade with the 3rd Regiment during the Campaign of 1777 and did not see Mr. Nelson – that he believes he died in service – (see the letter of January 3rd 1831, signed "J Marshall")
