Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

I do Certifie that John Jameson enlisted for 18 months the 1st of April 1779 & served as a Sergeant in Cl. Buford's Regiment till he was captured at Bufords defeat [Battle of the Waxhaws, May 29, 1780] after receiving several wounds & he never rec'd any pay nor was exchanged nor liberated [?]¹ till after the expiration of the time for which he was enlisted. 8 Oct. 1783 S/ Henry Bowyer, Lieut.

The bearer John Jameson wishes to have his wounds examined & certified to the Executive S/J Pendleton

On examination find John Jamieson has received a number of wounds by the broad Sword & Bayonet – two wounds on the left side of the Head & two on the back of the Head which he says at times affect him greatly & I believe he says truly – another wound in the Belly which has occasioned a partial rupture, he complains much of & I think with the reason – three fingers on the right hand are much injured & disabled; & a wound here the Humerus of the right arm, has done considerable injury – several slighter $[?]^2$ wounds he has also received – think him considerably disabled from Supporting himself by hard labor & that his Sufferings merit Compensation.

That John Jameson, aged about 35 years, Late a Serjeant in a detachment of the Virginia Line commanded by Colo. Buford and whose pay was at the rate of Thirty Six pounds per annum, Was disabled in the service of the United States by Several wounds received in his head and other places, And that he is allowed the Sum of Fifteen pounds yearly to commence from the first day of January 1786

Given under my hand as Lieutenant Governor of the Commonwealth of Virginia the Governor being absent and having previously specified [?] his intention of being absent to the Privy Counsel, and such intention having been entered in their Journals at Richmond this 7th day of May [?] 1787.
