[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

John King a Soldier wounded in the action of Colo. Beauford [Abraham Buford's defeat, or the Battle of the Waxhaws, May 29, 1780]¹ is permitted to pass with his father Samuel King to Virginia – Issuing Commissaries are required to furnish them with Rations, Forage masters with forage for one horse and Continental Ferry boats will pass them over ferries on their route to Virginia

S/ W. Smallwood, BG [William Smallwood]

Salisbury in North Carolina

22nd August 1780

The Bearer having obtained another horse for the convenience of himself & son is allowed forage for that horse also

This day Samuel King came before me an Alderman for said City and made oath that he received his son John King on the 22nd day of August 1780 at Salisbury Town in North Carolina from General Smallwood and Doctor Clements who informed him the said Samuel King that his son John had lost both his arms in Blufords defeat. Given under my hand this 19th day March 1788

I do, with the advice of counsel hereby certify that John King late a Soldier in the third Virginia Regiment and whose pay was at the rate of £24 per annum appears to have been disabled in such a manner while in the service of the United States as to enable him to the sum of eighteen pounds yearly: which allowance is in accordance made him, to commence from the first day of January 1786. Given under my hand at Richmond, this 20th day of March 1788.

Dumfries January 18th 1781

John King a Soldier of the third Virginia Regiment being enlisted during the War and having lost both his Arms in the action under Colo. Bueford in the State of South Carolina is entitled to [several illegible words] until the State of Virginia shall make ample Provision for her maimed and wounded. Issuing Commissaries are therefore required to furnish him with Rations 'till further Orders or the [two illegible lines] general supply him with Cloathing in the meantime given under my hand the Date above



[several undeciphered words] the Auditor's office to pay the bearer Samuel King the wages due his son it will be a real act of humanity and charity. His son John King in Col Buford's defeat had both his arms cut off [several undeciphered words] a situation the most helpless that can be conceived. His wages are due from Dec'r 77 [undeciphered] His father the bearer is a poor man, and any favor bestowed upon him will be [undeciphered] acknowledged.
