## Bounty Land Warrant information relating to William Radford VAS401 vsl 2VA Transcribed by Will Graves

Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call errors or omissions to my attention.]

I do hereby certify that Sergt. William Radford of Captain Holmes Company of Colonel Campbell's detachment was killed in the action of Eutaw Springs in South Carolina on the 8<sup>th</sup> day of September 1781

Entitled to depreciation from first January 77 to first September 79 as a private & from thence to 8<sup>th</sup> September 81 as a Sergeant S/T. Meriwether

For a valuable consideration I do assign to Francis Pierce the full balance of pay & bounty of land due William Radford deceased who service aforesaid enable him in Continental Regiment. S/ Jno. Radford

I Joseph Monk<sup>1</sup> of Chesterfield County Virginia do hereby Certify that I was well acquainted with William Radford and well recollect that he Enlisted for During the war of the Revolution in the Virginia Continental Service he served in Woodford's Brigade to the North and when the Army marched from the North he was Sergeant Major in Captain Bowyer's Company in Colonel Cambels [Campbell's] Regiment and at the battle at the Eutaw Springs South Carolina he was wounded and died in a short time afterwards he was a brave soldier. Given under my hand this the 22<sup>nd</sup> day of March 1833
