Pension application of Jesse Salmon [Salman] VAS402 vsl 15VA

As well as William Andrews, William Creedle [Criddle] and Harrison Jones

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Cumberland County November 29th 1785

A Letter from his Excellency the Governor was read in court requiring a report of the bodily abilities of the pensioners of this County enclosing a list of all the pensioners in this Commonwealth. Whereupon the court proceeded to make the following report

William Andrews Sergeant by a wound in the loins has lost use of his lower parts whereby he is totally helpless

William Creedle by the loss of his right arm while a soldier in the service of the United States is rendered incapable of procuring a livelihood by his own labor.

Harrison Jones by the loss of one of his legs in the battle of Guilford is likewise rendered incapable of procuring himself a livelihood.

Jesse Salman by many wounds he received in the battle of Waxsaws [Buford's defeat, May 29, 1780] has in a great manner lost the use of both his hands and is unable to labor.

The court was of opinion that the said William Andrews, William Creedle, Harrison Jones, and Jesse Solman or proper objects to continue on the pension list.

Cumberland Court January 22nd 1786

Pursuant of requisition from the counties concerning pensioners the Court have taken the following proofs and report accordingly

Mayo Carrington being sworn deposeth that William Andrews was a Sergeant in his Company in the 5th Virginia Continental Regiment that he was wounded at the battle of Brandywine in September 1777 by a musket ball which passed through his thigh of which he recovered and that on the 16th July 1779 he was at the storming of Stony Point Fort where he received a wound in the loins supposed to be with Can grape [?]² shot, whereby he was totally deprived of the use of his lower parts, the situation in which he now appears.

Mayo Carrington & Joseph Carrington deposeth that William Criddle was a private in the

2nd Virginia Continental Regiment that he lost his right arm while in the said Regiment at Norfolk in the month of January 1776.

Charles Ballew deposeth that Harrison Jones lost his leg at the battle of Guilford in March 1781.

The Court are of Opinion that the said William Andrews, William Criddle, & Harrison Jones are still persons that all to be continued on the pension list & that William Andrews all to be allowed £36 per annum – the pension for which he now stands on the list his wounds having rendered him totally helpless

The said Criddle \$5 per month

That the said Harrison Jones is in the same situation he was in when last reported and that he ought to receive [image cut off at this point]

That Jesse Salmon a pensioner in this County on the pension list died in October last and that in the opinion of this Court that his Creditors or legal representatives all to receive the Pension to the time of his death.

William Andrews of Cumberland about 30 years of age late a sergeant in ye 7th Virginia Regiment in last annual pay was 36 Pounds was wounded in the service of the United States allowed £18 per annum from first January 1786

William Criddle of Cumberland about 30 years of age late a private in ye 2nd Virginia Regiment lost his right arm in the service of the United States – Allowed £15 per annum from first January 1786

The Governor was obliged to leave Town before deliverables certificates could be prepared. They shall be put to the Auditor's Office when the Governor returns September 17, 1787

I hereby certify that I have examined the wound of William Andrews, which is under the ribs and from the injury done the spine or backbone, is my opinion rendered incapable of getting a subsistence by bodily labor.
