I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Cumberland May Court 1782

William Newton came in and made Oath that he served as a Sergeant on Captain Thomas Young's company of one of the battalions raised for the defense of the Western frontiers of this State according to an act of May Session 1779 that the certificate produced by him for such service is true and was by him duly obtained and that he has not before proved or claimed his right to land for the Services therein mentioned.

This day John Baskerville of lawful age personally appeared before me Simons Bolling a Justice of the peace for the County aforesaid & made oath that William Newton of the County aforesaid joined Colonel James Wood's Regiment at Albemarle barracks in Lieutenant Bernard Glenn's Company in the year 1779 and afterwards was placed in Colonel Joseph Crockett's Regiment & at or about the close of the war when the Troops were discharged he was acting in the capacity of Sergeant in Captain Thomas Young's Company in the latter part of December in the year 1781. Given under my hand & seal this 11th day of August 1812.
