Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

It appears from the Returns lodged in the War Office that Captain James Markham was captured by the British forces in April 1781 and remained a prisoner until the General Exchange on the first of May 1783.

You will perceive Sir, that Captain James Markham was a Captain in the Navy and served in that Capacity 7 years & 5 months the law placed him on the pay of Major in the land service – and he had issued to him

Captain for 7 years in the Navy this is exactly the pay for a Major – in the land service now as to the 5 months in addition to the 6 years and the one-year, the 5 months should be in the same proportion and a warrant No. 6174 for 277 ¾ issued for that amount by mistake in advice of Council and has been assigned to Captain Booker it would appear that it should remain with the present assignment and an additional warrant issued to Captain Markham so as to make up the deficiency to which he was entitled: & this statement with the proof is now submitted for consideration.

To all to whom these presents may come

James Markham of the County of Stafford Commonwealth of Virginia, send Greeting; Whereas as the said James Markham during the late war was a Captain in the Navy and thereby entitled to a considerable sum of money for his services as half for life or 5 years full pay in commutation agreeable to the laws of this State, and whereas the said Sum nor any part thereof half been paid, now know you that the said James Markham having and reposing great Trust and confidence in

Mr. Jacob Valentine of the County of Princess Ann, and Commonwealth aforesaid have made ordained constituted and appointed and by these presents do make ordain constitute and appoint the said Jacob Valentine my true and lawful Attorney, etc. [boilerplate PA language]... I have hereunto set my hand and affixed my seal this 11<sup>th</sup> day of February 1792.
