# Pension application of Richard Marshall VAS493 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Albemarle January 9<sup>th</sup>, 1791

Sir

The bearer hereof Mr. Richard Marshall is the wounded Soldier, that there was an act passed the last Assembly directing you to issue him a Warrant of twelve pounds for his present Relief, also placing him on the pension list. Given from under my hand the day & year above written.

Recit 26 Feb 91 a warrant for twelve pounds S/ Richard Marshall, X his mark

I do with the advice of the Council hereby certify that Ri and chard Marshall late a private in the sixth Virginia Regiment and disabled in the service of the United States, is put on the list of Pensioners with an allowance of twelve pounds yearly, commencing the first day of January 1791, pursuant to the Act of the General Assembly "for placing Richard Marshall & Robert Furguson on the List of Pensioners."

[The documents in this file are annual orders, court findings and direction to the sheriff to pay the pension and the veteran's receipt for same up to 1799 when on March 4, 1799, the court ordered the Sheriff to pay Mary Marshall, widow and relic of Richard Marshall the sum of \$30 being the amount due him up to the time of his death. The date of his death is not stated.

Speaker & Members of the General Assembly of Virginia the petition of Richard Marshall humbly Sheweth That your petitioner was a soldier in the Virginia Line during the late war & served out the full time of his enlistment that on account of very dangerous wound which he received at Camden in the year 1781 [probably the battle of Hobkirk Hill, April 25, 1781] which rendered him helpless for a long time (& still renders him unable to support himself) & from the

dispersed situation of the of the officers who were acquainted with your petitioner's misfortune he has heretofore been unable to settle his account & to obtain that relief which his deplorable & helpless situation requires, he therefore prays his case may be considered & such measures taken as shall seem proper to the Hon. Assembly & he will pray –

Certified that there was a Continental soldier belonging to the Virginia line in my company in the year 1781 by the name of Richard Marshall, that was wounded at the battle at Camden the 25<sup>th</sup> day of April the same year, that him – Lord Rodden [Rawdon], attacked General Green [Nathanael Greene], he was left on the ground, and taken into Camden by the British Army, sometime in September the same year, I see [saw] the same Richard Marshall, at the Hospital at Camden not well of his wound, though he could move on his crutch.

At a Court continued and held for Albemarle County the 12<sup>th</sup> of November 1790

Ordered that it be certified that Richard Marshall a [indecipherable word] & wounded Soldier is an Inhabitant of the aforesaid County, & that he is disabled from supporting himself & family, in consequence of his being so wounded; & that he is a proper object to be added to the List of Pensioners.

D. Sir

Your letter of the 4<sup>th</sup> of February was handed me by Mr. Field, which contained your Intercession in behalf of Richard Marshall, there was a man by that name in the company that was given me at Ramsey's Mills in North Carolina after I was exchanged at Charles Town [Charleston] and Joined that part of the Army Commanded by General Greene, and on the 25<sup>th</sup> of April 1781 at the Battle at Camden, the time Lord Rodden attacked General Greene, this same Richard Marshall was wounded in the Action, standing next man to myself, the retreat was ordered so soon after, I had not it in my power to send him off, and I was doubtful that he could [the image of the document cuts off at the bottom thereof at this point]

#### Albemarle County to wit

Samuel Standen this day made Oath before me James Minor a Justice of the peace for the said County that Richard Marshall a soldier in Capt. John Barbe's [sic] Company of the 2<sup>nd</sup> Virginia Regiment was wounded at the Battle of Camden on the 25<sup>th</sup> of April 1781, that he tended on him and dressed his wound for a considerable time in the Continental Hospital. Given under my hand this 12<sup>th</sup> June 1788

#### S/ James Minor

As well as my memory serves me Richard Marshall enlisted out of one of the State Regiments into Baylor's Dragoons December 79 and served the war & never was wounded as I ever heard of.
