Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

It appears by a list of such of the Officers and Soldiers in the Virginia line on Continental establishment as received certificates for the balance of their full pay or depreciation, that David Mason a Colonel in the said line received on the 23rd July 8 1784 a certificate for the sum of £235.1.4 – Given under my hand this 8th day of October 1831

I belonged to a company commanded by Captain James Mason which company was attached to the said Regiment. Captain James Mason was in the service 3 years or more sometimes commanding & sometimes on recruiting & other Service. Given under my hand this 23rd day of March 1831.

enlisted in Captain Cosmo Medici's Squadron of Horse, attached to Bland's Regiment the Virginia quota in August 1778, I was raised within a few miles of Colonel David Mason's residence in the County of Sussex and knew him well, I was in Pulaski's Legion encamped at St. John's Chapel in 1779 the British at that time lay in St. John's Island when Colonel David Mason arrived with the Virginia Troops and joined General Lincoln a few weeks before the Battles at Stony ferry [sic, Stono ferry, June 20, 1779], the battle at Stony Ferry took place as well as I now recollect in the month of June 1779 the above is strongly impressed on my mind from the circumstance of my having had my horse killed from under me at Stony Ferry and myself wounded, I was carried to the Hospital at Charleston and was attended by Doctor John Trisvant [?]² a native of South Carolina, and attached to the Army, I am now drawing a pension for life for services rendered to the end of the war of the revolution.

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 23rd day of July 1784, in the name of David Mason, as a Colonel for £285.1.4, which Certificate appears to have been delivered to himself and was given for services prior to the 1st January 1782, to wit as Colonel of 15th Virginia Regiment from 1st January 1777 to 31st July 1778
