Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

George Rice was a Captain of the 7th Virginia Regiment, and retired as a supernumerary Officer at the consolidation at White Plains on the 14th of September 1778. He was a brave and meritorious officer, and had been in active service from the year 1775 to the period of his becoming supernumerary. See extract from the Washington Papers herewith filed. From the 17th of November when a warrant for bounty land was issued to [name written over and illegible] Peyton a supernumerary Captain of the 3rd Virginia Regiment, up to the present day, under every administration of the Executive Department of the Government, Supernumeraries have been uniformly allowed bounty land from the period of their entering the service until the end of the War. The evidence in the present case is deemed conclusive, and the heirs of Captain Rice passed the additional bounty do you to their ancestor from the 1st of January 1782 to the end of the War. November 3rd, 1783.

To his Excellency the Acting Governor of Virginia

Your Memorialist respectfully represents to your Excellency that the Grandfather of this memorialist to wit George Rice was a Captain of the Virginia Continental line of the Army of the Revolution and has received from Virginia four thousand acres of land for his services as aforesaid and has been dead near fifty years ago leaving six children as will be shown more fully. at any time when necessary all of whom save one being now dead and three or four of them leaving families of children. Your memorialist has [indecipherable word] been induced to believe that his said Grandfather acquired a right to more bounty land from the State of Virginia in right of his said services as a Captain than was received by him. And having died at that early period the same has never heretofore been [indecipherable word] or applied for. He therefore prays your Excellency to take his case into your consideration and that you will grant to him and his co heirs the allowance of any such additional bounty land as shall be clearly shown is by law and uniform practice acquired a right to and your memorialist is in duty bound will ever pray.
