Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." I Certify that sometime in the year 1777 James Mill deceased did enlist as a Soldier under Drury Ragsdale who was a Captain in the Regiment of Artillery commanded by Colonel Charles Harrison, said Regiment was raised on Continental Establishment as well as I remember was to continue in service three years – the said James Mill departed this life before his term of service expired when the Regiment was with the Northern Army. Given under my hand this 22<sup>nd</sup> day of August 1821.

I do further Certify that John Mill is the sole Heir of James Mill deceased. Given under my hand this 24<sup>th</sup> day of September 1821

Sir

The Reverend John Mill of the County of King William has requested me to communicate to your Excellency and the Council of state that he is a brother James Mill died in the Continental service of the revolutionary war, and that he is sole heir to his said brother, and thereby entitled to the bounty land due for the services of his said brother. In confirmation of this claim I beg leave to forward the enclosed certificate, and to say that Mr. William H. Roane and probably [?] Mr. William F Pendleton can testify to the perfect respectability of the signature to the certificates, and if any additional testimony is requisite to show the fact of Mr. James Mills having been in the Continental service, that some records in the auditor's office will establish it.
