Bounty Land Warrant information relating to Christian Febiger VAS675

I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I was intimately acquainted with the late Colonel Christian Febiger from the year 1776 until the time of his death. On the 13th day of November 1776, he was appointed a Lieutenant Colonel in the Virginia line on Continental establishment. I was then a member of the House of Delegates, and had the day before Colonel Febiger's nomination, been appointed to the Command of a Regiment – it was made [to] appear to the Satisfaction of the Legislature, that Colonel Febiger had served with great reputation the year before as Adjutant on the expedition against Québec, where he was made a Prisoner of war. The Company to which he was attached, was commanded by the late General Morgan [Daniel Morgan], and marched from Winchester to join the Army in June 1775. I further certify that Colonel Febiger after his promotion to the Command of a Regiment, remained in service to the end of the War, which was determined by Congress to be the 15th day of November 1783.
