Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Upon the certificate of William Lewis formally a Major in the Virginia Line; Ordered that it be certified, that Mary Minton is the widow of John Minton late a Soldier in the Continental Virginia Line, who died whilst in captivity at Charlestown [Charleston South Carolina], during the late War

I do, with the advice of Council, hereby certify that Mary Minton widow of John Minton who was a private in the first Virginia Regiment and died in service of the United States, is allowed the sum of five pounds yearly, to commence from the first day of January 1788.

Given under my hand as Governor of the Commonwealth of Virginia at Richmond this  $8^{\rm th}$  day of January 1789.
