Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I Certify that I was well acquainted with Edward Moore who enlisted under Captain Robert Tompkins during the revolutionary war on board the *Henry*<sup>1</sup> Galley in the naval service in the capacity of a private or Seaman and that he served his time out and was honorably discharged.

As witness my hand & seal this 19<sup>th</sup> day of June 1832

To his Excellency John Floyd Governor of the State of Virginia in the petition of Richard Moore for himself and his sister the only surviving heirs of Edward Moore Deceased respectfully represent that his father the late Edward Moore was a soldier of the Revolutionary war. That he enlisted under Captain Robert Tompkins on board the *Henry* Galley for the war, and that he served faithfully and was discharged honorably. He refers to the certificates accompanying this petition and evidence of these matters. Your petitioner has every reason to believe that the said Edward Moore never did receive a land warrant for his bounty land annual petitioner now seeks to obtain that Justice in the premises, by which a recent act of Congress has been awarded to all those similarly circumstanced with himself. He therefore asked that a warrant may be granted him for the lands due to his father for his military services, and as in duty bound he will ever pray.
